# Unwelcome Serenade Has a Fatal Ending in Williamsburg.

Peter Novelin, fifty-six years old, of 31 Meeker Avenue, Williamsburg, early yesterday morning shot and fatally wounded Patrick Ketchma, forty years old, living in an adjoining house at 29 Meeker Avenue.

The shooting took place on the sidewalk at 31 Meeker Avenue.

Four weeks ago Ketchma enterlained some friends with music. Noveling remarked the following day that the little was discordant. This reached the ears of Ketchma. Saturday night Ketchma, with his friends, serenaded Novelino, who armed himself and went down stairs, accompanied by his sixteen-year-old daughter.

On the front stoop stood Ketchma, who

refused to move. Novelino opened fire and sent a bullet through his heart. Some of the serenaders also drew revolvers and shot at Novelino and his daughter, but fruitlessly.

Novelino was locked up, charged

with murder. There were also arrested of the serenaders Salvato Lugano, forty-three years old, of 31 Manhattan Avenue, charged with shooting at Novelino's laughter, and Nicolo Lonono, forty-three years old, of 29 Meeker Avenue, charged with carrying a loaded revolver. All were arraigned in the Manhattan Avenue Court before Magistrate Naumer, where Novelino was held without bail, Lugano in \$2,500 bail, and Lonono was held for trial at Special Sessions.

# Police Sergeant Louis Sharkey of the Ralph Avenue Police Station was counted

a hero by his comrades yesterday. Notwithstanding the fact that he had dined heartily at a Rockaway Beach beefsteak outing, he gallantly rescued four men from the capsized catboat Argus in Jamaica Bay.

It was his day off, and with four friends he was returning from the dinner in his naphtha launch. They were speed-

ing through a choppy sea off the Belle Harbor Yacht Club, when they saw the Argus capsize.

Sharkey steered for the craft. Four men were clinging to her keel, unable to swim. Sharkey jumped overboard and brought to his launch one man after the other. They proved to be Dr. Rudolph

other. They proved to be Dr. Rudolph Reese, Dr. William Rethfelder, William O. Arnold, and another man who did not give his name, but who asserted that all were from Brooklyn.

The rescued, the rescuer, and his friends landed at the Jamaica Bay Yacht Club, where restoratives were served.
